

SAFETY, HEALTH, AND ENVIRONMENTAL POLICY STATEMENT

SAFETY

We at Superior Environmental Solutions have a responsibility to ensure the safety and well-being of our employees, customers, outside contractors, business visitors and the general public as we perform our services and pursue the operation of our facilities. It is our firm and diligent commitment to eliminate accidents through every reasonable precaution and by aggressively promoting safe behavior both on the premises and at home. We believe that it is the desire of every worker to go home from work in the same shape he/she was in when they arrived.

Injury prevention and efficient operations go hand in hand, and no work activity is so important or urgent that it cannot be performed safely. The core values of the Company's safety philosophy can be summarized in the following.

- Safety comes first and must be actively managed everyday
- Understanding hazards, unsafe conditions, and unsafe acts prevents injuries and occupational illnesses
- Participation by all personnel creates a safe work environment
- Elimination and control of hazards, unsafe conditions and unsafe acts must be part of every process
- Reporting of incidents and unsafe conditions is essential to correct issues and prevent their recurrence
- Intervening to stop unsafe conditions and unsafe acts protects oneself, co-workers, and the public
- Operation of vehicles and equipment in a professional manner without distraction or impairments saves lives
- Responsibility for one's safety at work, at home, and on the road rests with every person

Each of us has a personal responsibility in incident prevention. We have a responsibility to our families, our fellow employees, our company and ourselves to perform our duties in a safe and productive manner. This requires that everyone understand and observe the safety rules as well as procedures related to the efficient and effective handling of their job. Under no circumstances, should anyone take an unnecessary risk that could cause injury.

ENVIRONMENT

Any SES employee who acquires knowledge of any claim, threatened claim, or anticipated enforcement action against Superior Environmental Solutions under environmental laws and regulations or discovers or believes that there is an existing or potential violation of environmental laws and regulations shall immediately notify an SES Executive Manager or the Corporate Safety Director.
